Organizations (RSOs)

PLEASE SUBMIT WAIVER & ARTWORK MOCK UP TOGETHER

Registered Student Organizations (RSOs), University Departments, and/or sponsored organizations and individuals using the Names, Trademarks, Service marks, logos, seals and/or other symbols (Marks) of the University in any commercial venture, including fundraisers and items resold for a profit will be charged a 12.0% Royalty fee of the cost of the product regardless of the selling price. Promotional products, free giveaways and team uniforms bearing the University's Marks, in conjunction with the names or logos of a RSO, University Department and/or University sponsored organizations, that are distributed exclusively to group's members and not sold individually are eligible for a Royalty Fee Waiver through the University Trademark and Licensing Administration.

Prior to the initiation of any commercial or non-commercial project using the University's Marks, this form must be completed and signed by the Director or Coordinator of the University Trademark and Licensing Administration. Vendors will be expected to charge the customers a 12.0% Royalty Fee on the cost of the products ordered if the customers do not provide an Approved Royalty Waiver at the time of the Sales order. Please note that any artwork bearing University Marks must also be approved by the University Trademark and Licensing Administration **PRIOR** to production.

Product orders without an approved Royalty Fee Waiver will be charged the standard 12.0% royalty rate on the cost of the products.
